The La Jolla Institute is a nonprofit biomedical research institute dedicated to increasing knowledge and improving human health through cutting-edge immunology research. Specifically, our researchers focus on understanding the immune response to infectious diseases and cancers and to advancing progress toward the prevention, treatment and cure of numerous diseases related to immune system function. Immune system disorders affect millions and include many of society's most debilitating illnesses. Our research focuses on four major disease areas: 1) AUTOIMMUNE DISEASES such as type 1 diabetes and rheumatoid arthritis; 2) CANCER and stimulating immune response against tumors; 3) INFECTIOUS DISEASES such as H1N1 (swine) flu, smallpox and West Nile virus; 4) ALLERGY AND ASTHMA and controlling harmful immune reactions. Regarded as a leading immunology research institute, the La Jolla Institute for Allergy & Immunology (LJAI) brings to bear a comprehensive research effort to understand the diverse aspects of immune-mediated diseases and to bring about further progress toward new therapies to help the millions affected by these disorders. Immune-mediated diseases are illnesses related to immune system functioning and include a broad array of disorders ranging from type 1 diabetes to infectious diseases to cancer. Led by a group of distinguished research scientists, the La Jolla Institute, a nonprofit biomedical research center, explores the body's immune system at the cellular level and is making important findings about why its malfunction causes many chronic, debilitating diseases, such as rheumatoid arthritis and Crohn's disease. Its researchers also explore how the immune system responds to infectious diseases and cancer and is using this knowledge to advance the development of new vaccines or cancer therapies that will boost the body's ability to fight these diseases. The Institute's work continues to draw significant notice in the scientific community. Currently, its overall research impact (as measured by citations per publication) places them among the top research Institutes in the world in two key categories -- Molecular Biology & Genetics and Biology & Biochemistry. In addition, three of its scientists are among the most highly cited immunologists in the world -- a distinction held by less than one half of one percent of all publishing scientific authors. Several of its faculty members also serve on National Institutes of Health (NIH) grant review panels, appointments that signal a high degree of respect from peers. Its scientists also regularly publish research papers describing their latest findings, many of these appearing in the most prestigious scientific journals. The Institute was founded in 1988 and is home to 22 independent laboratories, each operated by a leading scientist who oversees research efforts to analyze immune system functioning. Supporting these efforts are the Institute's more than 300 employees -- nearly half of whom hold doctoral degrees (Ph.D. or M.D.) from numerous countries around the world. LJAI receives the majority of its funding through competitive research grants from the NIH and is growing its philanthropic opportunities to fulfill priority needs. This includes funding for new areas of research, cutting-edge technologies and continuing recruitment of the very best scientists. The Institute is guided by a 12-member Board of Directors, which has included five members of the National Academy of Sciences. A scientific advisory board of distinguished outside specialists conducts annual evaluations of scientific progress and reviews future research objectives. LJAI researchers continued to make impressive research advancements in 2009, with more than 125 research papers published in scientific journals. Other major highlights included Dr. Hilde Cheroutre's selection for the prestigious NIH Director's Pioneer Award. The Pioneer Award annually funds a select group of researchers nationwide (only 18 in 2009) who propose novel, visionary approaches to major challenges in biomedical research. Also in 2009, the Institute expanded its research program through the addition of five new faculty members. Three of these scientists (Drs. Joel Linden, Lynn Hedrick and Nunzio Bottini) will enhance the Institute's work in heart disease, inflammation and diabetes, while the other two faculty members (Drs. Anjana Rao and Patrick Hogan from Harvard's School of Medicine) will focus on genomics research, and will lead the Institute's new Division of Signaling and Gene Expression. In addition, the Institute dedicated its Type 1 Diabetes Research Center in 2009, which was created to focus on novel immune-based approaches to this terrible disease. The Center is led by Dr. Matthias Von Herrath, one of the top type 1 diabetes researchers in the world and recipient of the 2008 Outstanding Scientific Achievement award from the American Diabetes Association. Eight Institute faculty members contribute to the Center's research. Lastly, the Institute's infectious disease efforts were significantly boosted in 2009 with the receipt of a major grant to battle some of the world's most dangerous infections. With \$18.8 million from the NIH, Institute researchers are working to provide data toward the development of first-ever vaccines for malaria and dengue virus and a better vaccine for tuberculosis, which kills about 1.6 million people each year. In addition to their research activities in 2009, LJAI scientists also lectured at medical research seminars throughout the world and organized numerous scientific conferences. While it is difficult to determine the number of persons benefited because of the broad applicability of the La Jolla Institute's findings and accomplishments, the Institute estimates that thousands of research and clinical scientists attended the above mentioned conferences, read the Institute's publications, and/or directly collaborated with our scientists, and as a result, now incorporate portions of our research into their work.
