These funds were transferred to Head Lama of TNMC and sent to Bodh Gaya. From Jan. 27 through Feb. 5, 2009, over
10,000 monastics, monks & nuns from India, Tibet, Bhutan, Nepal, & Sikkim as well as over 15,000 lay people recited
prayers for over 8 hrs/day. 1,000,000 butter lamps, 3,000,000 sacred art prints, 148,700 books, 10,000 prayer wheels,
and \$168,100 cash offerings to the monastics were offered. One way transportation was also given to the monks and
nuns in attendance. Daily food offerings were made to the assembly including a lunch of rice, tea, vegetables, and
1000 to 2000 local poor people were also fed a hot meal of rice, tea, and vegetables.
