Communities Empowering Youth In 2007, On Track (as the lead agency) received a 3-year federal grant to build the capacity of the lead organization, its faith-based and community partners, and the resulting collaboration to promote positive youth development and to improve outcomes for youth at risk of gang involvement, youth violence, child abuse, and neglect (CEY’s priority social service areas that define the program's targeted populations of at-risk youth) The goal is to strengthen a broad-based community collaboration that will better address the myriad issues that disadvantaged youth face

Physical Fitness & Nutrition Program In 2007, On Track received a 3-year federal grant to implement a comprehensive fitness, nutrition, and obesity prevention program with students, teachers, parents and the community at Kennedy Elementary in Santa Ana Included in this program is the Kids On Track through Mentoring & Fitness Program, which matches highly trained and supervised teen mentors with disadvantaged 3rd through 5th grade students

Youth Development Programs, General/Other Mentoring Children of Prisoners In August 2004, On Track received a federal Mentoring Children of Prisoners grant to match highly-trained and screened adult mentors with children, ages 4-18, who have a parent who is incarcerated in a State or Federal prison, while also providing support for the entire family Our On Track Mentoring Children of Prisoners program itself has initiated 647 matches to date, which equates to working with well over 3,000 participants since we provide resources for the families (parents, guardians, siblings)
