2009 Statement of Program Service Accomplishments

Project Rebirth's Strategic Review

A Living History of the Human Spirit Coping With Disaster

Project Rebirth is a film chronicle of the strength of the human spirit coping with disaster: the aftermath of September 11, 2001 at the World Trade Center. As a feature-length documentary combining 35 MM time lapse photography of the rebuilding of Ground Zero with the intimate stories of nine people coping post 9/11, Rebirth is the only living record of the minute-by-minute rebuilding of the WTC site and the only long term public film record of nine people dealing with grief and trauma. It will be a key component of the National September 11th Memorial and Museum and serve as the basis for a range of cutting edge teaching and learning tools for educational, training and therapeutic programs.

Chronicling Living History to Inform and Empower

Project Rebirth is creating a feature-length documentary that:

- **Engages global audiences** in a pure, apolitical and productive perspective on individuals' and communities' long term response to a major disaster
- **Inspires and enables viewers and collaborators** to devote energy and resources to:
 - Capturing and making best use of a unique historical record of the recovery from the destruction of the WTC;
 - Expanding the study and delivery of support for victims of mass trauma and grief.

Recording and Archiving History, Creating Powerful Film and Media, Reinvesting to Help Victims of Traumatic Loss

Phase I:

Record in the highest quality media the efforts to cope with and rebuild from the physical and emotional damage caused by the destruction of the WTC.

- Develop the financial and professional resources for a 12-15 year effort to capture the history of the recovery from the 9/11 attacks.
- Raise sufficient funds to ensure that as much as possible of the living history of the WTC rebuild is captured on the highest quality media available: 33 MM motion picture film – *before the opportunities are lost.*

Phase II:

Collaborate with World Class Partners to Advance Projects and Initiatives Closely Aligned with Rebirth's Content and Mission

- **Educate and inform, and support** victims of and first responders to major traumatic events
 - **Educate and inform:** e.g. creation of relevant curricula for students in line with Rebirth's mission to "Remember 9/11;" films for and installations in the National 9/11 Museum.
 - **Support:** e.g. content for services, therapies and research focused on disaster and large scale grief and trauma.
 - **Project Rebirth Educational Initiative** formed by leading teaching and learning centers at **Georgetown and Columbia** Universities.

Phase III:

Roll out revenue generating plans for distribution and presentation of our feature-length documentary in theaters, and across the full range of distribution channels. Coordinated with a nationwide grassroots effort to build awareness for the need to provide improved long terms care for grief and trauma following disasters, presentation of Rebirth's film and media will serve as a call to action for audiences to support the Project Rebirth Center.

Phase IV:

Reinvest commercial proceeds to endow the Project Rebirth Center for victims of and first responders to mass trauma and grief.

- The Project Rebirth Center will develop, gather, improve and redistribute therapeutic and educational/training resources for long term support for victims of and first responders to events of mass trauma and loss.
- This specialized resource will be the first of its kind, meeting and urgent and growing need to leverage existing academic, practical and profession skills and knowledge using leading teaching and learning tools processes.
- In parallel with the global release of Rebirth's feature-length documentary, the contributions of the Center to improving long term care for grief and trauma will directly leverage Rebirth philanthropic investment and mission.

2009 Review

In 2009, Project Rebirth made significant progress advancing the strategic imperatives outline above.

Timelapse filming of the rebuilding of the World Trade Center site proceeded as the pace of construction at the site continued to increase. The interviews and filming of our nine subjects continued and in 2009, the final annual interviews for the feature-length documentary film were completed. Rebirth will continue to film the reconstruction of Ground Zero until it is complete, adding to our unique film library, which will be used for exhibits in the National September 11 Memorial & Museum (NS11MM) as well as for educational, academic and therapeutic purposes.

In 2009, Project Rebirth created a film segment for the 9/11 Memorial Preview Site, a lower Manhattan venue created by the NS11MM to educate the public about the construction of the Memorial and Museum. By the end of the year, the Project Rebirth film segment had been seen by hundreds of thousands of visitors to the 9/11 Memorial Preview Site.

Plans continue to advance in the development of the Project Rebirth Center, a collaborative endeavor between Project Rebirth, Center for New Designs in Teaching and Learning at Columbia University (CCNMTL) and the Center New Design in Learning and Scholarship at Georgetown University (CNDLS). The Project Rebirth Center will meet an urgent need to help those who respond to mass casualty events by developing and distributing collaborative on-line teaching and learning tools to help communities be better prepared for the long-term grief and psychological trauma associated with major disasters.
