





This First Amendment to the Bylaws of the Lakeside Legacy Foundation (the "First Amendment") is made this 20<sup>th</sup> day of July 2009, pursuant to Article XV of the Bylaws of the Lakeside Legacy Foundation (the "Bylaws").

**WHEREAS**, the Bylaws of the Lakeside Legacy Foundation (the "Bylaws") were duly adopted by the Foundation on May 7, 2003 and have been amended from time to time; and

**WHEREAS**, Article XV of the Bylaws authorizes the Amendment of the Bylaws by a two-thirds vote of the Directors present at any regular meeting or at any special meeting, provided at least ten (10) day written notice is given.

**WHEREAS**, certain changes to the Bylaws to modify certain procedural components of the Bylaws have been proposed; and

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by a two-thirds vote of the Directors present at a regular meeting held on July 20, 2009 that Article IV. **BOARD OF DIRECTORS**, Section 2 and Section 10, and Article VI. **OFFICERS AND EXECUTIVE COMMITTEE**, Section 1 and Section 6 shall be deleted in their entirety and the following new Article IV., Section 2 and Section 10; Article VI., Section 1; and Article VII. **OTHER COMMITTEES**, Section 5 shall be inserted and shall state as follows:

**ARTICLE IV. BOARD OF DIRECTORS**

**Section 2.** Number and Term of Office: The number of members of the Board of Directors shall be eleven (11), effective March 18, 2009. One third of the Directors shall be elected for a term of three (3) years or until their successors are elected. Each term shall begin on January 1<sup>st</sup> and shall end on December 31<sup>st</sup> three years later. A director elected to fill an unexpired term, shall be considered to have served three (3) full years regardless of the period of time actually served. Each member of the Board of Directors shall be a member in good standing of the Lakeside Legacy Foundation. Directors shall be residents of the greater Crystal Lake, Illinois, area. Directors may succeed themselves in office, but no Director shall serve more than two (2) terms in succession, except that during any term that a Director also serves as an Officer, this term shall not be included in the computation of the two (2) successive terms that may otherwise disqualify the Director from serving on the Board for the next term.

**Section 10.** Quorum: The presence of a majority of the currently filled board positions shall constitute a quorum for the transaction of business at any meeting of the Board of Directors, provided that in no event shall a quorum equal less than five (5) Directors. If less than such a number is present at a meeting, a majority of the Directors present may adjourn the meeting from time to time without further notice.

## **ARTICLE VI. OFFICERS AND EXECUTIVE COMMITTEE**

### **Section 1.**

Vice President of Board Development: The Vice President of Board Development shall be responsible to the Board of Directors for matters pertaining to the recruitment, nomination, orientation, training, and evaluation of candidates for the Foundation's Board of Directors, in accordance with established policies and practices approved by the Board of Directors.

**Section 6.** Executive Committee: The Executive Committee shall consist of the President, Immediate past President, Vice President, Vice President of Board Development, Secretary, and Treasurer. The Executive Committee shall be responsible for the day-to-day affairs of the Foundation but shall not assume any powers specifically assigned by the Bylaws to the Board of Directors or to individual officers. If the need for policy or procedural decisions arises between meetings of the Board of Directors, the Executive Committee shall have the power to make such decisions, subject to ratification by the Board.

## **ARTICLE VII. OTHER COMMITTEES**

**Section 5.** Advisory Board: The Board President may appoint, with the approval of the Board, an Advisory Board, consisting of not to exceed 20 members, to assist the Board in promoting the objectives of the Foundation and to advise the Board of Directors concerning the overall image of the corporation within the community it serves. The Board President shall appoint the Chair of the Advisory Board. The Advisory Board shall have no authority or ability to act independently or to bind the Board of Directors or the Foundation. The Advisory Board members shall serve for one-year terms (or such shorter terms, depending upon their date of appointment), expiring on December 31<sup>st</sup> of each year.
