Women and Children's Shelter

The Women and Children's Shelter provides immediate, temporary solutions to those who find themselves homeless due to domestic violence, poverty, and other circumstances beyond their control. In a safe and welcoming environment, case management is provided to women and their families to begin to address the issues surrounding the circumstances that led to their homelessness to help develop more permanent solutions. In 2009, 11,140 nights of lodging and 33,417 meals were provided to women and their families along with advocacy and aftercare transitional services to provide more permanent solutions.

Drop In Center

The Drop In Center addresses the immediate needs of the marginalized and homeless population in the Cleveland area by providing services such as meals, clothing, phones, showers, mailboxes, and first-line medical attention for health issues resulting from exposure. In 2009, 63,042 meals, 63,024 bags of clothing and 19,856 instances of street survival and advocacy services were provided to individuals and families in need.

Housing

The Zacchaeus Housing Program empowers individuals and families by providing permanent solutions to homelessness through limited rent subsidy and case management. Priority for acceptance is given to those who are unable to control their living arrangements due to displacement and/or other issues and are temporarily unable to pay market rent. In 2009, 58 adults and 81 children were successfully placed in permanent housing.
