	Part I, Line 4a	Blanchard Valley Health System contributed on behalf of Scott Malaney \$75,044 to a Supplemental Executive Retirement Plan (SERP). The SERP is an unfunded, nonqualified deferred compensation arrangement consisting of two plans: an "eligible" plan subject to Internal Revenue Code Section 457(b) and an "ineligible" plan subject to Section 457(f). The 457(b) plan was implemented effective January 1, 2002; the 457(f) plan was originally effective September 1, 2000 and was restated on January 1, 2002 for coordination with the 457(b) plan. Key features of the SERP include the following: * Eligibility is limited to certain management or highly-compensated employees of BVHS (i.e., "top hat" reference). Future participation is upon nomination by the CEO and approval by the Committee of the Board. * Employer contributions are a combination of: ** Restoration benefit - equals the present value of the benefit that the executive would have accrued under the qualified defined benefit plan except for the statutory pay limitation that applies to qualified plans (e.g., \$245,000 in 2009). ** 15% of base pay - each participant's 457(b) account will be credited up to the statutory limit (\$16,500 in 2009), with the remaining amount being deposited into the 457(f) account. * Each participating executive is eligible to make elective employee deferrals to the 457(f) plan ranging from 1% to 100% of compensation and/or bonus. * Vesting provisions of the employer contribution portion of the 457(f) plan mirror those of the qualified defined benefit plan (i.e., five years of service). The 457(f) benefit also becomes fully vested if the executive dies, becomes disabled, or if a change of control occurs. * The SERP includes a non-competition agreement which states that all 457(f) benefits (employer and employee contributions) will be forfeited if the executive directly or indirectly competes with BVHS during the forfeiture period, which extends for two years after termination. * Distribution of the vested portion of the 457(f) benefit is paid as a lump sum as soon as administratively feasible after the expiration of the forfeiture period (two years after termination) providing the executive has not violated the non-competition agreement.
