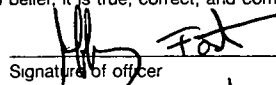
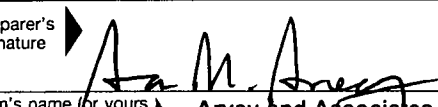

The Emergency Shelter operated at full capacity throughout the year but 1,189 requests for shelter in 2009 were denied due to lack of available bed space.
