## **Combined Program Service Accomplishments for Sunshine Communities**

In 2009 the Foundation contributed \$1,743,526 to the charitable mission of Sunshine Inc. Residential and Support Services and Sunshine Inc. Vocational Services.

- Grants provided enhancements for therapeutic riding, the arts program, capital improvements and equipment purchases
- 700 donors made contributions in support of our mission
- A new emphasis on planned giving was launched with the introduction of The Engler Society, a program of recognition for those who made planned gifts
- 575 volunteers donated 7965 hours of service
- A new fund, Susan's Smiles of Happiness was started by a parent to raise funds to pay for dental work

In 2009, Sunshine Inc. Residential and Support Services served individuals with developmental disabilities, achieving the following:

- 80 individuals with significant medical and/or behavioral conditions served in the central intermediate care facility
- 91 individuals served in community group homes
- 128 individuals served in their own home with supports ranging from 5 hours per week to 24 hours per day depending on their needs
- 156 individuals served in respite, a temporary residential service designed to provide a break from caretaking responsibilities for families
- 44 individuals served by an intervention program designed to support families with children who have intensive behavioral needs
- 13 families served in a program designed to help parents with developmental disabilities raise their children
- 50 individuals served in a weekend recreation program
- 969 families linked to services through a family resource program administered by Sunshine on behalf of the county board of developmental disabilities

In 2009, Sunshine Inc. Vocational Services served individuals with developmental disabilities, achieving the following:

- 152 individuals received adult day services offering enrichment activities and employment opportunity
- 67 individuals received supported employment
- 52 individuals received therapeutic horseback riding
- Paid employment opportunities increased
- The arts program expanded
- The coffee and gift shop expanded sales while providing employment opportunity for a growing number of individuals with developmental disabilities
- The greenhouse program expanded with addition of a hoop house constructed by volunteers
