HELPED INCREASE AFFORDABLE HOUSING BY 4,000 UNITS. THE FOUNDATION HAS GIVEN GRANTS TO AGENCIES TO AID THEM IN BUILDING CAPACITY WHILE MAINTAINING CURRENT SERVICES. THIS IS A CONTINUING AND GROWING PROBLEM IN THE CLEVELAND AREA DUE TO AN INCREASE IN JOBLESSNESS AND THE DOWN TURN IN THE ECONOMY.
