Line 28 - Boone County Farm Bureau, Inc. sponsored Ag Day breakfast. 50 people, including Farm Bureau board members and county officials, attended this breakfast.

Ten volunteers contributed in preparation, planning, and coordinating the activities for this event, for a total of 25 volunteer hours.

Boone County Farm Bureau's intention was to participate in discussion with county leaders, such as commissioners, council members, special board members, school board members, and school officials, in order to present the County Farm Bureau's goals and concerns.

Boone County Farm Bureau contributed \$176 for breakfast. Financial support, along with 25 hours of personal time and energy was provided to make this event possible.

Line 29 - Boone County Farm Bureau, Inc. partnered with the Boone County Chamber of Commerce to sponsor two legislative breakfasts in two separate months. All county citizens were invited to visit with all state legislators serving Boone County.

Six volunteers contributed 20 hours to plan and coordinate the activities for these events

Approximately 35 citizens attended each breakfast, one of which was held in Lebanon, IN and the other in Zionsville, IN. These citizens were given a chance to discuss legislation with their government representatives in an informal manner.

Boone County Farm Bureau paid \$613 in order to advertise the breakfasts to local citizens. Financial support, along with 20 volunteer hours of personal time and energy went into planning this event.

Line 30 - Boone County Farm Bureau, Inc. hosted two policy development meetings. A committee of Farm Bureau members met and discussed policies and local issues that they would like to see created into state and national legislation.

Twelve Farm Bureau members volunteered for a total of 50 hours to plan and carry out these meetings.

Boone County Farm Bureau's intention was to develop policy recommendations to send the Indiana Farm Bureau, Inc. committee on resolutions in order to give further support and more reach to the ideas.

Boone County Farm Bureau, Inc. contributed a total of \$80 for a place to host the meeting and meals during the meeting. Financial support, along with 50 volunteer hours made these meetings possible.
