	<p>Membership The Valparaiso Family YMCA serves over 17,000 members and program participants each year mainly in Porter County, Indiana with programs and services that build strong kids, strong families and strong communities In 2009, the Valparaiso Family YMCA provided 247 memberships to local group homes and human service agencies and subsidized memberships, program fees and childcare assistance to low-income families to more than 525 men, women, and children in our community!
