We served 3,031 clients and their families. We distributed 3,973 cases of nutritional supplement. We provided financial assistance to clients in the amount of \$116,072. We also provided 539 transportation trips for cancer treatment. Other services include provision of personal health supplies, wigs, support groups, and information and referral.

Education services to people with cancer, professional medical people, and the community at large. Fifty-five people attended an educational symposium and we participated in 35 health fairs.
