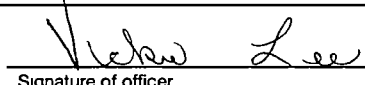

The Friends of Johnson County Public Library is an organization consisting of local community volunteers who sell used books, weeded by the Library and donated by the public. The book sales are held for 4 days, 4 times annually, for a total of 16 days. The money generated by the sales is donated to the Library and used by the Library to purchase prize incentives for our Summer and Winter Reading Programs, hire entertainers and professional people for seminars and workshops, all of which are not able to be funded by public tax dollars in the state of Indiana.

Membership dues are minimal - annually \$5.00 for an individual and \$10 for families. Benefits to members are few, allowing them to attend the opening night of the sales to have first choice to purchase the books.

All Friends funds are either donated back to the Library for our programs or saved for future requests and act as a 'cushion' to guarantee program funds if a book sale is not successful.
