

Gateway Ministries is designed to plant outreach centers by setting up local churches through out the region. These churches will reach out to their communities with food distribution, community based events, along with networking with other InnerMission outreach programs such as marriage helps, shelters, food pantries, soup kitchens, etc. Through our Spanish Ministries we reached out to 6-7 families with food boxes through out the year.

4b (Code:) (Expenses \$ 273,552 including grants of \$) (Revenue \$)

Dream Center - The Dream Center distributes food/clothing to families in need. In 2009, the Dream Center provided food and/or clothing to over 880 individuals. Approximately 1,800 to 1,900 bags of groceries were given out. The Dream Center also includes Caring Hands Soup Kitchen which provides food and fellowship to people in need. The kitchen has been open on Saturdays for over 20 years. We serve a hearty and hot meal to a diverse group of people (40-80 per week) including the homeless, unemployed, working poor, public assistance recipients, elderly and many with health problems and disabilities. In 2009 we served 750 individuals, prepared 2548 meals and fed people on 52 Saturdays.

After School Programs - The After School Program provided after school care five (5) days a week for children from K-8th grade. The program was free until September when we began to charge \$25 per child per week. The program assisted 18 families during 2009. Total enrollment for 2009 was 39 children. During the summer, we provided a Summer Day Camp five (5) days per week for children from K-5th grade. The fee was \$25 for the first child and \$20 for each additional child. The summer program assisted 7 families during 2009. The total summer enrollment was 10 students.
