DEPLOYMENT PROGRAMS Nonviolent Peaceforce teams in Sri Lanka continued to provide international presence, monitoring, and protective accompaniments of human rights defenders in the capital, Colombo, and 3 districts. In collaboration with local civil society and the United Nations Development Program, Nonviolent Peaceforce developed local capacity for peacekeeping and for increased security of vulnerable populations, including children. In Mindanao, Philippines, Nonviolent Peaceforce was officially invited by the Government and the Moro Islamic Liberation Front to join the Civilian Protection Component (CPC) of the International Monitoring Team. We are currently the only international nongovernmental organization in the CPC. In addition to our offices in Cotabato City and Manila, our peacekeepers live in seven field sites, providing daily visible protection and training local peace monitors and advocates.

ADVOCACY AND STRATEGIC RELATIONS Through presentations at conferences and cooperative efforts on common issues, Nonviolent Peaceforce continued to advocate for the use of unarmed civilian peacekeeping with organizations throughout the world, including the Catalan Parliament in Barcelona, the European Union, the European Commission, the Organization of American States, the U.S. Congress, and the United Nations. In addition, Nonviolent Peaceforce began planning a deployment of peacekeepers in Sudan, and explored the possibility of deployments in the South Caucasus and Honduras.

TRAINING & CAPACITY BUILDING In 2009, Nonviolent Peaceforce continued to build the capacity for large-scale unarmed civilian peacekeeping deployments through Mission Preparedness Training. After rigorous screening, selected applicants - all with prior field experience - completed the intensive three-week training in the Philippines. Participants came from countries around the world, including Russia, Croatia, Liberia, Ghana, Nigeria, the DR Congo, the United Kingdom, Bangladesh, Sri Lanka, Uganda, Kenya, Sierra Leone, the Philippines, and France. Deployments to Sri Lanka and the Philippines required additional demanding in-country orientation and training.
