The Senior program service consist of the facility open to the public and providing, socializing, lectures and a meal at cost on three Wednesday of the month. Volunteers provide the cooking and serving. On the average 170 Seniors take part throught the whole year.

The youth program service provides a structured program for approx. 30 teenagers with instructors to teach drama, singing and folk dancing. Facility provides dedicated space for socializing for the group.

The children program service, pre-teens, also provides a structured program singing, games and folk dancing for about 65 chilgren.

The children and youth group organize food drives and perform in community events and nursing homes.

The above program services are staffed all year by many volunteers.
