ESTABLISHED IN 1966, CHRISTIAN MINISTRIES FOUNDATION (CMF) PROVIDES STEWARDSHIP SERVICES TO CHRISTIAN INDIVIDUALS AND ORGANIZATIONS. THESE SERVICES INCLUDE CHARITABLE TRUSTS, DONOR ADVISED FUNDS, CHARITABLE GIFT ANNUITIES AND ENDOWMENT ASSETS FOR THE BENEFIT OF THE CHURCH AND ITS MINISTRIES WITHIN THE UNITED STATES AND THROUGHOUT THE WORLD. TO-DATE, CMF HAS DISTRIBUTED APPROXIMATELY \$92 MILLION IN GRANTS TO CHARITIES AROUND THE WORLD. CMF ALSO PROVIDES BACKROOM ADMINISTRATION AND ACCOUNT OVERSIGHT TO OTHER CHRISTIAN ORGANIZATIONS AND MINISTRIES.
