Annual conference of professionals from various disciplines, including health and human services providers, academics and researchers. In addition to expert keynote lectures, break-out sessions are offered in 3 time slots during the day. Added this year were poster and exchange sessions which allowed practitioners, researchers, faculty and students to present information on evidenced-based services to seniors, to bring awareness about research relevant to those working with aging populations, and to highlight new services that address emerging critical issues, such as elder abuse. Conference attendance is between 250-300 attendees. Scholarships are awarded to up to 3 students in gerontology. CEU's are provided to attendees.

4b (Code) (Expenses \$ 25,002 including grants of \$ 0) (Revenue \$ 42,200)
Co-production of a one-hour TV program with TPT, the local public television station, on research and practice related to senior transportation, driving and community alternatives. In addition to the public television station, there were 11 other organizational co-sponsors. In addition to the program airing on television, 3500 DVD's were produced to distribute to Minnesota groups and families. The program will help older persons and their families in decisions related to driving, using available resources for safe driving, and in finding alternative transportation options when driving is no longer safe. Program is being aired regularly on three public TV channels over one year. A resource and discussion guide was produced by MGS and made available for download to use in viewing the

Educational programs including 5 webinars, providing continuing education for those working with seniors and doing research related to services for seniors. Webinar topics included work and retirement, health disparities among older people, using logic models to assess results, understanding eldercare abuse, and kinship care by grandparents. Attendance averages about 20 in each webinar. A bi-monthly e-newsbulletin alerts members to events, resources and data which can strengthen their work or research with older persons. Other resources are available on the MGS web site and in the MGS membership directory which enables different disciplines to collaborate on aging projects. The Minnesota Gerontological Society has been an all volunteer managed organization until 2006 when the Board decided to use some reserve funds to hire a 1/4 time Executive Director to manage more outreach beyond the Twin Cities Metropolitan Area to the total state of Minnesota and expand the services of MGS. Programs were expanded to include webinars, resources on a newly developed website, collaborations with other organizations, including the transportation program with the local public television station and other transportation and aging/disability organizations, and including the initiation of the statewide network of Gerontology Educators with the University of Minnesota Center on Aging. The annual Conference was expanded to include more identification and sharing of research on aging issues, and more best practices for aging service, beyond the keynote lecture and the 12 breakout sessions. A poster and exchange component was added, which resulted in 14 additional offerings to the 250 participants. The organization undertook strategic planning sessions in order to develop increased organizational capacities to manage and expand the programs, especially reaching the diverse disciplines working in the aging field in
