Therefore board meetings are ad hoc & usually held at our board chair and president's house in White Bear Lake, but we don't take minutes because we are all volunteers and don't have membership per se.

11. Our only annual gathering is to review our tax filing with (for state of Minnesota) which usually occurs in late February or March depending on the press of other, productive activities.

19. We have provided our articles of incorporation and by laws occasionally to external groups that ask including once earlier this year. Usually they are seeking models of how to do save-the-world education. We do not have a written conflict of interest or whistleblower policy because we are tiny & it would be ridiculous for a small group of volunteers who do not pay anyone and raise most of our money from a single fundraising letter late each November. Every check we've ever written in 27 years + tax filings are maintained in our small office in my basement.
