	International ServicesCVT directly provides psychosocial services to adult and child victims of torture in Sierra Leone and the Democratic Republic of Congo, and concluded its programming in Liberia in April In Jordan, CVT provides psychosocial and physiotherapy services to Iraqi torture survivors and their families who fled Iraq to seek safety in Jordan In addition, professional expatriate clinicians recruit, hire, train and supervise national staff, many of whom were refugees or internally displaced during their countries' war, to be paraprofessional psychosocial counselors and work under the direction of the professional staff CVT extends its services through large-group and community wide sensitization events, small-group counseling, and individual counseling CVT assists 18 treatment centers outside the United States that have the potential to become regional leaders in the treatment movement, providing technical assistance and targeted financial support to enhance clinical skills and ensure their organizational survival by strengthening administrative infrastructures The treatment centers are in Guatemala, Peru, Kosovo, Romania, Bulgaria, Ethiopia, Sierra Leone, South Africa, India, Cambodia, Pakistan, Palestine, Bangladesh, Kenya, Namibia, Sudan, Uganda and Cameroon

	TrainingCVT provides training for health care and human services professionals, educators, refugee and resettlement workers, students, attorneys and other persons involved in refugee and asylum matters, and representatives from other healing centers for torture survivors This training focuses on clinical issues related to providing care to torture survivors as well as institution-building and organizational development strategies through CVT's National Capacity-Building project In 2009, the project partnered with the U S Department of Health and Human Services, Office of Refugee Resettlement, to create and pilot a "blended learning" online course called Fundamentals for Providing Services to Torture Survivors CVT continues to serve the West Metro area of the Twin Cities through the West Metro Schools project CVT also provides administrative support to the National Consortium of Torture Treatment Programs To promote other promising innovations, CVT launched the New Tactics in Human Rights project in 1999 Working with a broad array of leading international organizations and activists, CVT promotes tactical, innovative and enhanced strategic thinking within the human rights community and provides training on this method

	Client ServicesCVT offers a multi-disciplinary care and rehabilitation program for survivors of torture and members of their families This unique and integrated program of care involves the professions of medicine, psychiatry, psychology, social work and nursing, the average duration of the program is about eighteen months CVT also offers consultation and referral services for torture survivors who cannot travel to CVT for care, as well as individuals who are not eligible or appropriate for CVT's services In 2009, CVT concluded the East Metro project, an effort aimed at conducting modest capacity-building activities with agencies serving refugee populations In 2009, CVT treated 249 clients in its Minneapolis and St Paul healing centers

	The careful task of healing individual torture survivors has provided CVT with a unique body of knowledge and experience, as well as a unique authority about torture CVT has found that it has an effective presence with state, national and international policy makers, that presence has given voice to healing groups emerging in the United States and abroad, providing them access to tell their stories and find new allies and resources In the Public Policy/Education program, CVT works cooperatively with human rights, religious, media and civic organizations to educate policy makers and the public about the effects of torture on individuals, their families and their communities, the intent of torture and the need for expanded resources to heal its survivors It is through this program area that CVT carries out its torture prevention activities as well CVT conducts ongoing research to describe its client population (demographic background, trauma and torture history, presenting diagnoses, symptoms, and complaints), patterns of service utilization, and responses to treatment The research program focuses on developing a methodology that will allow CVT and other treatment centers serving torture survivors to document changes in physical, psychological and behavioral adaptation that are meaningful for a culturally diverse torture survivor population Findings are disseminated through written and oral presentations in a variety of professional and lay forums ranging from scholarly journal articles and professional meetings to training presentations and media contacts CVT also assists three international partners to build their research and program capabilities
