EXAMPLES OF THESE ACTIVITIES ARE EARLY LITERACY, SUMMER READING, AFTER SCHOOL AND TEEN LITERACY PROGRAMS. IN ADDITION TO THESE PROGRAM INITIATIVES, SPECIAL PROJECTS INCLUDE BRANDING, KIOS RADIO PROGRAMMING AND WEBSITE DEVELOPMENT. IN A "I LOVE THE LIBRARY!" CAMPAIGN, OVER \$342,000 WAS RAISED TO ALLOW THE FLORENCE LIBRARY TO REMAIN OPEN IN ADDITION TO PREVENTING REDUCTION OF HOURS AND SERVICES.
