product from national and regional manufactureres, wholesalers, retailers and growers
for distribution to 140 non-profit programs (soup kitchens, food shelves and other
charitable programs) as well as in-need people directly throughout NE MN (St. Louis,
Carlton, Lake and Cook Counties) and NW WI (Douglas, Bayfield, Ashland and Iron
counties). We did this utilizing 5,825 hours of volunteer service from over 400
volunteers saving our food bank over \$64,000 in expense. We estimate that our food
fed over 40,000 people in need throughout our region in 2008.
