Retention Program To ensure that students of The Cara Program have the tools they need for long-term self-sufficiency, The Cara Program utilizes an "aggressive outreach" approach throughout each student's first year of employment These services include regular one-on-one meetings with employed students about on-the-job successes and challenges, development of individual long term goals, including housing, education, debt repayment, access to and encouragement of a matched savings program (which supports a 5 1 match in savings, up to \$1,000), and much more As a result of this retention support, over 70% of employed Cara students remain in their first job placement for at least one year This outpaces nationwide average one-year retention rates for the same industries TCP serves by over 20 percent Included in Retention is the Self-Sufficiency Initiative, supported by The Eleanor Foundation, in which The Cara Program has had the opportunity to provide 100 women with two years of personalized and intensive counseling and service, as part of the Organization's long-term strategic expansion In these two years, TCP focuses on career advancement, increase in earnings, accumulation of wealth and resolution of debt, educational attainment, and leadership development
