Highlights for FY2009 include the December graduations for 2 of the KHW residents after completing their 15-month programs. The total direct beneficiaries for FY2009 is 4 men who were discipled at the KHW. Indirect beneficiaries include over 25 immediate family members with whom the men are reconciling and rebuilding godly relationships. Other indirect beneficiaries include the four local churches directly involved in mentoring the residents in 2009.

4b (Code:) (Expenses \$ **38,718.** including grants of \$ **0.**) (Revenue \$ **0.**)**Meet Me at the Gate (MMATG)**

Train and equip the Church to minister to Christians coming out of prison; identify and train individuals interested in establishing post-prison ministries of their own; work with local, state, and federal officials and persons within the Department of Corrections to facilitate prison reform; educate the general public concerning the need for post-prison ministry.

Highlights for FY2009 include 3 MMATG seminars/workshops held in IL, TN and WI with over 150 people in attendance; networking with local radio station (WMBI 90.1 FM) to broadcast their July 23rd Morning Show live from the Lake County Jail (IL); networking with Desiring God Ministries to enable them to produce a video in prison to reach the Afro-American urban population; consulting with numerous families and their incarcerated loved ones to provide encouragement and network resources to help with transition after release.

Educate, motivate, and minister to incarcerated persons to prepare them for potential release into society.

FY2009 highlights include 4 special meetings at Lino Lakes Correctional Center (MN) with Prison Fellowship's IFI program participants; conducting 40 services in 10 prisons and jails in IL, LA, MN, TN and WI.
