

**Note 1 - Nature of the Organization**

Help Save Pets (the Organization) is a not-for-profit corporation organized in the State of Illinois since 2000. Help Save Pets is dedicated to strengthening the public awareness of humanitarian treatment, the rescue and placement of homeless animals at the community level, and further educating the public of the problem of pet overpopulation and offering solutions for ending it.

**Note 2 - Summary of Significant Accounting Policies**

**Financial Statement Presentation**

The Organization follows the recommendations of the Financial Accounting Standards Board (FASB) in its Accounting Standards Codification No. 958-205, *Not-for-Profit Entities; Presentation of Financial Statements* (formerly Statement of Financial Accounting Standards (SFAS) No. 117, *Financial Statements of Not-for-Profit Organizations*). Under FASB Codification No. 958-205, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. During fiscal years 2009 and 2008, the Organization had no temporarily or permanently restricted net assets. In addition, the Organization is required to present a statement of cash flows.

**Revenue Recognition**

The Organization accounts for contributions in accordance with the recommendations of the FASB Accounting Standards Codification No. 958-605, *Not-for-Profit Entities; Revenue Recognition* (formerly SFAS No. 116, *Accounting for Contributions Received and Contributions Made*). In accordance with Codification No. 958-605, contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support depending on the existence and/or nature of any donor restrictions.

All contributions are considered to be available for unrestricted use unless specifically restricted by the donor. Contributions are recognized as revenue when the commitment is received.

All donor-restricted support and revenue is reported as an increase in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a temporary restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

## **Note 2 – Summary of Significant Accounting Policies (continued)**

### **Inventory**

Inventory is priced at lower of cost and market, with cost determined on a specific identification method, and market based the lower of costs incurred to get pets ready for adoption or estimated net realizable value.

### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### **Cash and cash equivalents**

Cash held by the Organization at December 31, 2009 and 2008 totaled \$39,757 and \$32,838, respectively, and consisted of money maintained in a checking account at The Private Bank. The balance is fully insured by the Federal Deposit Insurance Corporation (FDIC).

### **Income Tax Status**

The Organization is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code. The Organization has been classified as an entity that is not a private foundation within the meaning of Section 509(a) and qualifies for tax deductible contributions as provided in Section 170(b)(1)(a)(vi). There was no unrelated business income for the years ended December 31, 2009 and 2008.

Help Save Pets has elected to defer provisions of FIN 48, Accounting for Income Taxes, under provisions of FSP FIN 48-3. The organization uses a FAS 5, Loss Contingencies, approach for evaluating uncertain tax positions and continually evaluates expiring statute of limitations, audits, changes in tax law and new authoritative pronouncements.

### **Office Furniture and Equipment**

The Organization has no office space. Normal activities are supported by the volunteers who contribute their time and work at each of their homes. Hence, the Organization has no office furniture or equipment since it began operations.

### **Reclassifications**

Certain accounts in the December 2008 financial statements have been reclassified for comparative purposes to conform with the proper presentation in the current year financial statements. These reclassifications had no effect on the net assets or changes in net assets as of or for the year ended December 31, 2008.

**Note 3 – Due (to) from KVS**

As of December 31, 2009 and 2008, the Organization owed \$1,624 and was due \$3,501, respectively, to Kremer Veterinary Service Corporation (KVS). KVS has been affiliated with the Organization since it began operations. KVS holds the pet inventory at their locations, provides medical services and charges the Organization for those services, and collects adoption fees on behalf of the Organization.

**Note 4 – Pets Inventory**

Pets inventory totaling \$6,456 and \$12,118 at December 31, 2009 and 2008, respectively, represents the value of pets available for adoption at year-end.

**Note 6 – Net Assets**

As of December 31, 2009 and 2008, unrestricted net assets totaled \$44,589 and \$48,457, respectively.

**Note 7-Recent Changes in Accounting Pronouncements**

FASB Staff position 117-1, is not applicable to the organization, and as such has not been adopted. The organization does not currently have an endowment. Statements of Financial Accounting Standard (SFAS) 157, is used for fair value measurements of financial investments and liabilities. The organization has delayed implementation until such time as there are investments.
