Recipient organization's work is exemplary and daunting in the face of paucity of funds, poverty, illiteracy of parents unwilling for social changes, difficulty in getting dedicated teaching staff, etc. The organization continues to do better and school children are showing remarkable performance in their studies, grades, social behavior, and bringing respect and esteem to parents, a measure of much needed social change.
