

## Articles of Incorporation – Nonstock Corporation

### The Park Foundation of Waukesha, Inc.

Executed by the undersigned for the purpose of forming a Wisconsin nonstock Corporation under Chapter 181 of the Wisconsin Statutes.

#### Article 1

The name of the corporation is The Park Foundation of Waukesha, Inc.

#### Article 2

The corporation is organized under Chapter 181 of the Wisconsin Statutes

#### Article 3

The name of the initial registered agent is Ron Grall.

#### Article 4

The address of the initial registered office in Wisconsin is City of Waukesha Dept. of Parks, Recreation & Forestry, 1900 Aviation Dr., Waukesha, WI 53188.

#### Article 5

The address of the initial principal office in Wisconsin is City of Waukesha Dept. of Parks, Recreation & Forestry, 1900 Aviation Dr., Waukesha, WI 53188.

#### Article 6

The corporation may not have fewer than three directors.

#### Article 7

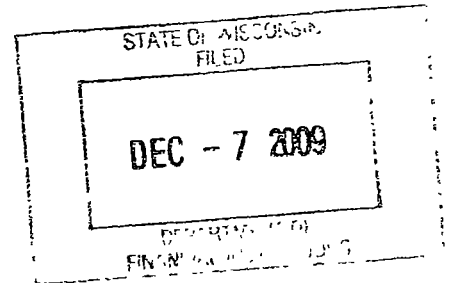
The corporation is authorized to make distributions under Wisconsin Statutes §181.1302(2), (3) and (4).

The corporation will not have members.

#### Article 9

The corporation's purpose will be to raise funds, invest and manage those funds to support improvements and activities at, and the greater public use of, city parks within the City of Waukesha, Wisconsin, and such other charitable activities as defined in Internal Revenue Code §501(c)(3) as may be determined from time to time by the corporation's board of directors to be in furtherance of that purpose. The corporation may not engage in any activities which would threaten the corporation's tax-exempt status under Internal Revenue Code §501(c)(3).

## **Article 10**

No part of the corporation's net earnings will inure to the benefit of, or be distributable to, its members, directors, officers or other individuals, except that the corporation is authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the corporation's activities will be the carrying on of propaganda or otherwise attempting to influence legislation; and the corporation will not participate in any way in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be conducted by a corporation exempt from federal income tax under §501(c)(3) of the Internal Revenue Code, or by a corporation to which contributions are deductible under §170(c)(2) of the Internal Revenue Code.

## **Article 11**

These Articles may be amended in the manner authorized by law at the time of amendment, consistent with both Chapter 181 of the Wisconsin Statutes and §501(c)(3) of the Internal Revenue Code.

## **Article 12**

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all the remaining assets of the corporation to the City of Waukesha Department of Parks, Recreation & Forestry, or its successor department, solely for uses consistent with the purposes stated in Article 9.
