	Supporting Families Together Association is a managing coordinator for child care resource and referral agencies. Community-based child care resource and referral agencies are local/regional organizations that are funded to systematically support high quality child care through focused services to families, early care and education professionals, and communities. The Association supported partner child care resource and referral agencies through technical assistance and coordination in delivering 11,010 customized child care referrals to families for 15,840 children. 26,563 families also received technical assistance about choosing child care, parenting, child development, or resolving difficult child care issues. 60,081 child care providers received technical assistance, and nearly 21,000 professionals participated in training and professional development opportunities. Furthermore, the Association worked with child care resource and referral agencies on greater consistency, quality assurance, outreach, and education, project coordination, and re-organization of service delivery to improve access to and sustainability of services.

	Supporting Families Together Association's staff and contractors deliver on-site and telephone pre-licensing technical assistance to potential licensed child care providers. Written information about the licensing process was provided to 1,054 prospective licensed child care providers. There were 607 on-site technical assistance visits ranging from two hours at family child care programs to a total of four hours on-site at prospective group centers. Over 3,608 technical assistance sessions were delivered via telephone. Child care program policy reviews were conducted for 620 prospective programs to ensure guidance toward sound business, safety, and child care practices. Furthermore, 2,845 instances of general technical assistance were provided to potential or newly licensed child care providers.

	The Children's Trust Fund and Supporting Families Together Association have continued to partner to build opportunities for family resource centers and child care resource and referral agencies to work together to promote primary prevention and high quality early care and education. In addition, the Association has played a significant role in cross systems efforts related to professional development, prevention of abuse and neglect, family supports, and promotion of positive child outcomes. In addition, the Association worked on policy/research efforts related to early care and education and conducted a study about expulsion rates in early care and education in Wisconsin.
