Facts And Circumstances Test
Galesburg Community Foundation ("Foundation") is a collection of funds and resources that support the efforts of local people and organizations to foster and promote a healthy community. Accordingly, the Foundation's governing body consists of a diverse group of individuals representing various professions and organizations in the community. The Foundation serves two essential segments in the make-up of the community: local charities working to improve the quality of life for the community and donors who generously give financial contributions to support the causes they care about. By using direct mail solicitation to prior and prospective donors to solicit contributions, the Foundation uses donor funds received to provide grants to non-profit organizations and scholarships to area students. The Foundation normally receives more than half of its total support either directly or indirectly from public contributions prior to the two-percent exclusion. Of the Foundation's contributions received, approximately one-third of the donors gift less than \$5,000. After the two-percent exclusion, the Foundation still receives a substantial part (greater than ten-percent) of its support from the general public as reflected on Schedule A, Section C.
