

The Executive Director is the key monitor of this policy in his role as top executive of the Festival as well as the conduit between the Board of Governors, volunteers, staff and the public at large. Any potential issues related to conflicts of interest are directed to his attention.

The Executive Director reached his one year anniversary of employment with the Festival in December, 2009. During 2009, the Executive Director met with all Festival's paid staff for their annual performance review. Staff was asked to complete a self-appraisal and this document served as the starting point of conversation.
