The YWCA Children's Center - a component of the YWCA's Women's Economic Empowerment programming - nationally-accredited (by the National Association for the Education of the Young Child), licensed by the State of Michigan and serves children from the ages of 6 weeks through school-age, in five developmentally-sequenced rooms Infant, Toddler, Pre-school, Older Pre-school and School-age Designed to meet children's social, emotional, physical, and cognitive needs, the YW-Children's Center provides a variety of activities that encourage individual development and learning and nurture social and emotional growth in a respectful, diverse environment The YW-Children's Center is one of very few child care centers in the Kalamazoo community which offers tuition assistance and accepts government subsidies The Center links with other YWCA services to ensure access to child care for all eligible program participants

The YWCA Mentoring Program - a component of the YWCA's Women's Economic Empowerment programming - provides support and encouragement to women seeking economic and personal self-sufficiency and girls at risk for not completing high school, by matching them with trained mentors Mentors provide individualized personal support, encouragement, guidance and friendship, while helping mentees identify and achieve goals and positively direct their own futures Mentees set educational/employment and personal goals and work to achieve them In addition, the program provides individual resource assistance and job/scholarship application assistance YWCA Community Services - addresses the YWCA's focus on changing unjust systems that perpetuate racism, sexism, violence and poverty, in order to achieve our vision of peace, justice, freedom and dignity for all people We accomplish this by educating the community and actively engaging in public policy advocacy on these issues Racial Justice components include Eliminating Racism training, Summit on Racism activities (implementing an annual work plan focused on dismantling institutional racism, culminating in an annual conference), intervention and advocacy Community awareness events regarding gender equity include the annual YWCA Women of Achievement Awards, Women's Equality Day, Pay Equity Day, etc
