|           | <p>Delta Dental Fund's (DDF) purpose is promoting dental education and research, advancing dental science, and promoting oral health of the public by providing funds for charitable projects. DDF has been committed to this purpose for over two decades. Over that time, thousands have benefited from grants and scholarships the Fund has provided. Since 1980, the inaugural year for the Fund, over 500 dental students have been supported through the scholarship program. Again in 2009, eight students from each of the five dental schools in Michigan, Ohio and Indiana, The University of Michigan (U-M), University of Detroit Mercy (UDM), The Ohio State University (OSU), Case Western Reserve University, and Indiana University (IU), received financial grants through the Fund to apply toward the cost of education. DDF has provided over \$1 million dollars in scholarships over the past 29 years. In addition to providing these scholarships, the DDF also continues to recognize fourth year dental students from each dental school with the prestigious Student Leadership Award for their outstanding commitment to dentistry and to their communities. Since 1982, the Fund has awarded 84 Student Leadership Awards totaling over \$140 thousand dollars. Education does not stop with graduation. Continuing education is necessary to stay current with advancements in treatment and policies and is mandatory to maintaining a license in some states. DDF assists practicing dentists by sponsoring and co-sponsoring seminars in dental science and related topics. In 2009 the Fund in addition to regional seminars, sponsored and supported the following: The Ohio Dental Association's 2009 Leadership Institute, The Detroit District Dental Association's Dental Review, Michigan Oral Health Coalition Conference and Annual Sessions sponsored by the Michigan, Ohio and Indiana Dental Associations. On the research front, 2009 marks the second year we've awarded more than one-hundred-thousand dollars in research grants for Master's thesis awards and faculty research. As always, this year's grants are supporting a wide variety of research topics. For example, we awarded fifty-thousand dollars for faculty research at the University of Michigan School of Dentistry and the Indiana University School of Dentistry. The U of M researchers will be looking at improving health communication strategies and oral health literacy. Meanwhile, the Indiana University researchers will be studying the effectiveness of the early sealing of dental caries. The Fund also is in its second year of a three-year grant totaling four hundred and fifty thousand dollars for the operation of the mobile dental coach operated by The Ohio State University College of Dentistry. The mobile coach provides dental treatment to Columbus, Ohio schoolchildren and is creating a wonderful record of accomplishment. In a single year, the coach will see nearly two thousand children and more than seven thousand procedures will be performed, including oral exams, sealants, teeth cleanings, x-rays and fillings. Another mobile dentistry program also is benefitting from our support through a six-thousand, four-hundred dollar grant to the Ottawa County Health Department's Miles of Smiles program. Our matching grant partnership with the West Michigan Dental Foundation has allowed this mobile dental clinic to provide much-needed dental services to low-income, non-Medicaid eligible children. In Indiana, we continued our support of the SEAL Indiana program with a twenty-five thousand dollar grant. This mobile dental sealant program, operated by the Indiana University School of Dentistry, offers preventive services such as examinations, dental sealants and fluoride varnish treatments. The program travels to schools within a one-hundred twenty mile radius of Indianapolis, treating children from low-income families who are not receiving or do not have access to routine dental care. In all three states, for the third consecutive year, we continued the Community Mini-Grant Program, which provides grants of up to \$5,000 to organizations for local oral health projects. The Foundation has committed up to \$70,000 for the program this year. Another great program we supported was in Detroit. The Give Kids a Smile Day held at the University of Detroit Mercy School of Dentistry. We provided two-thousand five-hundred dollars in support of the event, plus we helped arrange for a visit from then-Detroit Mayor Ken Cockerel. 2009 also marks the second year of our three-year commitment to the U of D Mercy School of Dentistry to assist with funding their new dental school on the Corktown Campus. Our grant is earmarked for the Emergency and Screening Clinic that provides care to the under-served. Thanks to our support, the clinic is serving an increased number of patients at the new location. We have a continuing collaboration with the Donated Dental Services Program, which is operated by the National Foundation of Dentistry for the Handicapped. Delta Dental provides office space in Farmington Hills for program staff and our president and CEO, Dr. Tom Fleszar serves as vice chairperson of the NFDH board. In addition, every year we provide a grant for the NFDH's DentaCheques program. Proceeds from the sale of DentaCheques are used to fund the important work of the foundation, which focuses on helping needy disabled and elderly patients gain access to dental care. Other programs the DDF supported in 2009 include - Annual support for the Capuchin Dental Program at the Jefferson House in Detroit. This program provides dental services for recovering alcoholics and substance abuse men in the Detroit area. - In Ohio, we funded the Dental Minute, a series of public service announcements on oral health arranged by the Cincinnati Dental Society and Delta Dental of Ohio. The announcements are regularly run on WKRC - TV 12 in Cincinnati. While these represent some of the major projects of the Delta Dental Fund, activity also includes distributing oral health information and toothbrushes at no charge to community and dental groups. In 2009, the Foundation's grants addressed all areas of our mission, with fifty-one percent addressing dental treatment for the underserved, sixteen percent for dental education, twenty-seven percent for dental research projects and six percent for dental school initiatives. This brings our total support for oral health projects since 1980 to nearly twelve million, seven hundred thousand dollars.</p> |         |                        |         |                     |
