EDUCATION Programs provided by the Brain Injury Association of Michigan included an annual two-day conference with over 1,200 persons (unduplicated count of 1,119 with brain injuries, their family members, professionals in the field of brain injury, insurance and medical professionals Over \$3,947 in reduced registration fees were provided to 42 persons with brain injuries and/or their family members The annual Strategies for Living Conference was not conducted due to limited interest A new annual specialty conference was created "Let's Talk About Sex" that focused on relationships and sexuality was held 130 attendees were registered, 15 attendees received financial assistance and 14 exhibitors participated Members and the general public were able to utilize the Association's library and resource room, which contains thousands of articles, books and videos Brain Injury Association of Michigan materials were distributed at over 64 community events and professional meetings ACBIS In 2009, 140 professionals applied to become Certified Brain Injury Specialists Since the inception of this program in 2003, Michigan has maintained the lead in the total number of CBIS' nationwide at 14% (600 certificants) GRANTS Ten educational scholarship grants of \$ 1,000 each were awarded to graduating high school seniors pursuing a career in either health care or rehabilitation fields This program is the result of the support of Special Tree Rehabilitation Systems

SUPPORT SERVICES FOR INDIVIDUALS WITH A BRAIN INJURY AND VETERANS, CHAPTER SUPPORT1) In conjunction with the Brain Injury Association of America, BIAMI agreed to partner as one of the National Brain Injury Information Centers (NBIC) in 2009 BIAMI staff was a pilot site for this service during the past year and in 2009 it was made official A single nation-wide toll-free number routes calls made in Michigan directly to BIAMI staff BIAMI staff also serves as a regional hub for this system during times when national staff are unable to handle calls 2) Support Programs include 21 chapters and support groups throughout Michigan which meet monthly with over 300 people attending each month Staff responded to over 4,000 calls on the toll free telephone line requiring over 500 hours of support Individualized packets of information were sent to assist families and persons with brain injuries New in 2009 was the use of social media that created many additional inquiries BIAMI uses Facebook, Twitter, and U-Tube with over 800 followers by the end of 2009 In addition, a new and greatly enhanced website with over 40,000 visits and in excess of 80,000 pages viewed has broadened our communication with members and the general public When searching on Goggle for "brain injury association," our Association ranked fourth 3) The Survivors' Committee met periodically and organized recreational activities In the spring, a shopping "Spring Fling" weekend was held for 74 persons with brain injuries and their family members During the annual conference, the Committee planned, organized and conducted a dinner and dance for 195 members The cost of this event was \$4,846 and was sponsored by the Association 4) A TBI Ombudsman position (part-time) was created in June, 2009 through funding of the State of Michigan's Department of Community Health's TBI Grant This position will work to develop relationships with the State of Michigan's Ombudsman office as well as all of the state agencies that persons with a brain injury are likely to come into contact with Through this network of agencies' staff, the Ombudsman is expected to assist persons with a brain injury and their families obtain needed services 5) During 2009, the Veterans Program continued as a result of the funding through the State of Michigan's Department of Community Health's TBI Grant This year, staff conducted ten briefings for 2,771 returning Michigan soldiers and hosted nine recreational activities that impacted 1,556 veterans These activities served to fulfill one of the program's purpose was to provide support and information about traumatic brain injury to veterans and their families, in particular those being deployed to Iraq and Afghanistan, as well as Veterans Service Organizations and VA County Counselors Additionally, staff advocated with the Veterans Administration regarding the services required by persons with a brain injury New in 2009 was the focus to assist in the development of a Police-Veteran Intervention Group
