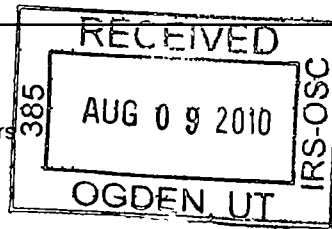



The Foundation was formed to receive and administer funds for the benefit of charitable purposes and to lessen the financial burdens of the Government of the State of Michigan, to raise funds from the general public, to finance certain expenses that would otherwise be incurred by Michigan taxpayers, and to support and encourage service projects initiated by Michigan communities, charities, and self-help organizations that promote volunteerism and cultivate community enhancement efforts.
