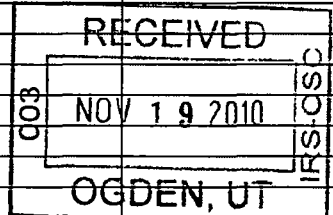

A nonfamily trustee may be removed with or without cause by Jack L. De Witt and Mary L. De Witt, or after the death or incapacity of both by the affirmative vote of all but one of the Family Trustees.

ELECTION OF ADDITIONAL TRUSTEE

RESOLVED, that STEVEN BUTLER is elected to serve as an additional trustee pursuant to Article III, Section 4 of the Bylaws of the Foundation.

ELECTION OF OFFICERS

RESOLVED, that the following persons are elected to offices set forth opposite their names to serve at the pleasure of the Board until the officer's death, resignation or removal.


