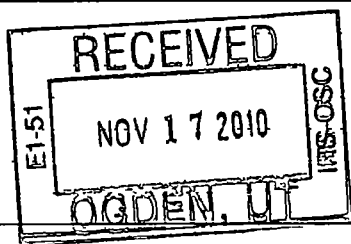

Also, to educate the community concerning literacy by making presentations at area organizations, maintaining a reference library and collaborating with other agencies.
