These executives must be in active regular service of ThedaCare Inc. for the entire plan year (January 1, 2008 to December 31, 2008) to receive their 2009 bonuses. If the employee retires, becomes disabled, moves to a position that is eligible under the bonus plan or moves to a position that is no longer eligible for the bonus plan or dies, the plan will be prorated for the amount of time they served the company. If an eligible employee is fired or leaves the company for any other reason, the plan bonus earned will be forfeited. Caring for Success. The plan objectives are to provide incentive to focus the organization's resources, energy and attention on the fulfillment of ThedaCare's mission. The organizational measure is ThedaCare's actual operating profit over budget. All eligible employees (on the payroll as of July 1, 2009 and still be on the payroll as of March 15, 2010) share in the gain. The payout amount is determined based on ThedaCare's operating margin and reduction in OSHA recordable strains and sprains. The amount per employee is determined by dividing the total gain realized (the employee share) by hours paid to all eligible employees.
