 The organization provides Supportive (Assisted) Living Services for frail elderly via its licensed Community Based Residential Facility (CBRF) known as the Courtyards at Luther Manor (CALM).  The organization provides safe and supportive independent living housing and services for older adults via its Luther Manor Terrace (LMT) Apartments. Apartment residents often chose the LMT in order to become part of a Continuing Care Retirement Community (CCRC) setting. The LMT Apartment services and amenities include life enrichment, transportation, dining, spiritual, wellness, fitness, health, entertainment and cultural programs
