Child Care Community Action's Community kids programs provide age appropriate educational programs using professional, state-licensed teachers for children ranging in age from 1 day to 12 year Located throughout Rock and Walworth Counties, our service sites include six easily accessible community locations and six area schools Flexible scheduling provides full and part-time opportunities 423 children were served in 2009 through our community centers with 74% coming from low-income homes An additional 169 children participated in before-after school programs or our four year old kindergarten programming with the Janesville School District
