Asset development programs which provide resources to businesses to create jobs for eligible individuals and training to improve skills of low-wage workers to increase their income Asset Development Programs are primarily supported through federal and state government grants 90% of the funds received to support this program are sub-contracted out to 10 501(c)3 organizations to operate the program Through the Skills Enhancement Program alone through the 4th quarter of 2009, There have been 38 Skills clients who have successfully exited the program (many more are participating in the program and will be successfully exiting the program in 2010)These 38 clients now have average wages of \$10 86 per hour (an increase of 32% equal to \$2 60 per hour) They have increased the average number of hours per week that they work to 33 7 hours per week (an average increase of 37% equal to 9 hours per week) 54% now have employer-sponsored health care vs 21% before becoming a Skills client

Conference Attendance for AHFE and Homelessness included 292 registered participants, attendance for Poverty Matters! included 212 registered participants WISCAP also sponsors quarterly meetings of its membership and the four quarterly meetings in 2009 had registered attendance of 482 participants
