	Women's Harm Reduction Program In 2009, 343 women were referred to the Benedict Center through Deferred Prosecution Agreements, Alternatives to Revocation (of Probation or Parole), Community Corrections, Children's Court, Prison Re-entry and Jail or House of Correction 95% of the women fulfilled their court obligations and 75% completed treatment goals or were continuing in the program at year-end Successful completion of Benedict Center programming usually earns the woman a dismissed or mitigated sentence, avoidance of revocation and reincarceration, and initiation of family reunification when appropriate 25% left prior to completing their goals and obligations for various reasons, including illness, employment, dismissed case and, rarely, re-arrest Within the Women's Harm Reduction Program each woman participates in setting her own goals in conjunction with fulfilling the requirements of the Courts or Department of Corrections During their time at the Center, women variously raise their literacy levels, earn high school equivalency diplomas, gain control over their addictions, learn to manage anger and stress, develop good parenting skills, participate with their children in family nurturing, engage in healing groups to cope with childhood sexual abuse, accept referrals for mental and physical health problems, participate in groups on women's sexuality and healthy relationships, develop financial literacy, focus on health and wellness, prepare for successful employment, engage in customer service training, participate in victim/offender/community Justice Circles, perform community service, enter recovery, secure employment, move on to college or technical training, participate in ongoing peer support groups and return to volunteer as sister mentors, public speakers, and office assistants - sometimes as paid staff

	The Justice Advocacy Program carries out the Benedict Center's work for fundamental change in the criminal justice system by demonstrating what works and best practices through the Women's Harm Reduction Program and other community alternatives its justice advocates help initiate, like the Community Justice Resource Center and Neighborhood Justice Centers In 2009 the Center participated with the National Institute of Corrections in the evaluation of the new Milwaukee County Community Justice Council, a collaborating body that includes all criminal justice and local government leaders The Benedict Center is the public representative on the Council's Executive Committee and also participates in planning and policy development on issues of Programs and Interventions, Public Health, and Community Education and Outreach The Benedict Center Executive Director is also involved in state and national criminal justice issues, recently completing service as regional vice president of the International Community Corrections Association and with the executive committee of the National Alliance of Sentencing Advocates and Mitigation Specialists At the State level, the Executive Director served on a Legislative Council Special Committee on Justice Reinvestment Oversight, charged with making significant policy recommendations to the Legislature for the 2010-11 state budget Some of the other significant works of justice previously initiated through Benedict Center advocacy include County Board approval of a new jail in a safer, more humane direct supervision mode, Revolving Bail Fund for indigent pretrial detainees, Restitution Work Program as an alternative to incarceration at the House of Correction, Court Monitoring in conjunction with the League of Women Voters, CARS (Court Alternative to Revocation and Suspension), Alternative Placement and Sentencing Directory, Community Justice Resource Center (day reporting center) and a pilot South Side Community Justice Center serving a diverse population that is predominantly Latino Under the umbrella of Justice Advocacy the Benedict Center launched a Sentencing Advocacy Project in 2005 to construct community-based sentencing plans in conjunction with the federal and state public defender, children's services, private defense counsel, and probation officers Though the program was inactive in 2008, a new business plan was prepared during the year to re-establish the program in 2010 or early 2011 Sentencing plans promote structured, effective alternatives to incarceration based on the defendant's social and criminal history, needs and strengths, community resources and opportunities for community service, restitution and/or other restorative processes in respect to the victim and community The Sentencing Advocacy Project has prepared cases in Milwaukee, Door, Waukesha, Ozaukee, and Racine Counties, and one federal case in Cook County, IL SAM (Sentencing Advocacy in Milwaukee) made its debut in 2004 as a searchable, web-based clearinghouse of community alternatives to facilitate alternative sentences for the increasing numbers of nonviolent defendants coming through the Milwaukee County Jail A major update of SAM began in 2008 and remains underway The Benedict Center's goal is to merge the site with a similar effort underway in the State Public Defenders Office, another being developed by the Wisconsin Department of Corrections and yet another prepared the Mental Health Association and Milwaukee Addiction Treatment Initiative (of which the Benedict Center is a convener and policy member)

	Jail Library The Jail Librarian circulated books, and periodicals to a daily populating of 900 Milwaukee County Jail inmates from a donated and purchased collection of more than 15,000 titles Approximately 60% of the inmates took advantage of library services until November when the Sherfff arbitrarily decided to shut down the libraries at the Jail and House of Correction Until November, the Librarian worked in concert with Milwaukee Public Schools and Milwaukee Area Technical College instructors, as well as reading group volunteers, to create a culture of reading and writing in the Jail The Benedict Center continued the reading groups and obtained permission to work with Inmate Workers to establish small libraries on housing units supported by voluneer rotation of books in 2010

	Interfaith Jail Chaplain The Chaplain coordinates the jail ministry work of more than 200 volunteers who provide Bible and prayer groups, counseling, Qur'an study, religious rites and services and spiritual support to the 900 men, women and youth incarcerated in the Milwaukee County Jail on a daily basis The Chaplain and her volunteer assistants work directly with about 2,500 inmates and several hundred families Restorative Community Service The Restorative Community Service Coordinator works with teams of 5 to 6 men and women fulfilling alternative community sentences at the Community Justice Resource Center Modeling the work ethic of the coordinator, the teams provide services to residents and nonprofits in neighborhoods most affected by crime and poverty They provide service to demonstrate accountability for the harm their offenses have caused, to improve the wellbeing of the community and to practice good work habits as they transition from treatment and classroom studies to employment More than 20 neighborhood sites served daily in 2009 include Habitat for Humanity, Salvation Army Feed the Kids and Toys for Tots, Second Harvest of Wisconsin, the Wisconsin Humane Society, 8th District Graffiti Removal Project, and numerous food pantries and community gardens Sisters Project Although the Sisters Project was inactive in 2008 due to the absence of sufficient funding, a federal appropriation approved late in 2009 enabled reactivation of street intervention to women working in drugs and prostitution Sisters Project street teams include women who have worked in prostitution, including women who have graduated from the Benedict Center Program The Project works closely with neighborhood organizations and block watches in troubled areas, as well as the Police and Community Partners
