Transitional Living Services provides supportive residential services for adults with a chronic mental illness who are in need of a structured environment Services may be short- or long-term depending upon the individual's needs The services place emphasis on psychiatric rehabilitation so that individuals may work towards moving to a less restrictive setting During 2009 supportive residential services were provided to approximately 175 individuals
