Common Wealth Development administers seven units of housing for a special needs population, manages eight units of housing, four of which house low-income physically disabled people, manages twenty-seven units of affordable rental housing, sold two properties (single family houses) in a first-time home ownership program, manages the Yahara River View Apartments, a 60-unit mixed income housing facility, and conducts housing program planning

Common Wealth Development manages a 42,000 square foot business incubator, manages two units of commercial space, manages a 50,000 square foot light industrial facility, provided small business technical assistance and referral, investigated the feasibility of siting of a public market in Madison, participated in the predevelopment of an arts incubator to be located at the former Garver Feed Mill site, manages an arts incubator, and promotes Williamson Street businesses through the Greater Williamson Area Business Association
