In 2009, the Wisconsin Coalition Against Domestic Violence (WCADV) hosted twelve statewide topical trainings for domestic violence victim advocacy staff and participated in trainings in a number of non-WCADV sponsored events More than 1,200 individuals participated in WCADV-sponsored trainings WCADV staff attended 476 meetings with 2,568 other attendees Meetings included participation by a broad range of victim advocacy, justice, health, economic, and human service professionals to provide expressive arts experiences to children with emotional and behavioral disorders

In the 2009-10 session, the Wisconsin Coalition Against Domestic Violence's policy advocacy was instrumental in passing legislation that further addressed housing safety issues for victims and created wide-scale reform of Wisconsin's restraining orders Policy staff worked with government agencies to address economic issues for victims, funding for services, and implementation of firearms policies as they relate to domestic violence offenders

Wisconsin Coalition Against Domestic Violence's staff were involved in 1,950 technical assistance contacts during 2009 Of those contacts, 68% of staff technical assistance contacts involved services to local domestic violence programs
