The Combat Blindness Foundation supported the building of the secondary surgical center of Dr Shroff's Charity Eye Hospital in Rampur, U P India The hospital is considered one of the best specialty eye care institutions in north India with an unwavering commitment to providing quality eye care services to all economic sections of the society The hospital serves a population of 14 million in New Delhi and surrounding areas and in its satellite locations in Alwar (Rajasthan), Rewari (Haryana), and Gurgaon (Haryana) Over 7,000 free cataract surgeries have been performed at both the Dr Shroffs Charity Eye Hospital in New Delhi and the mobile outreach center in the Alwar District
