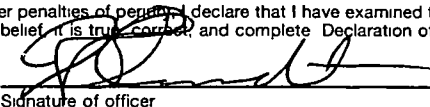
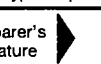

Transitional Housing for homeless single adult women and families--Hope House provides transitional housing to 14 single women and 10 families. In 2009, 80% of residents obtained permanent housing upon discharge. In addition, 51% of residents who were not disabled had obtained employment upon leaving the program, and 75% had utilized 3 or more supportive services during their stay. Fusing best practice research, consumer input, and 20 years experience, Hope House has developed a method that includes the following: 1. Extended Shelter and Supportive Case Management, 2. Comprehensive Assessment and Service Planning, 3. Practical Onsite Education, 4. Consistent Reinforcement and Role Modeling, and 5. Referral, Linkage, and Engagement to Community Based Services. Using this method, Hope House has consistently achieved benchmarks that exceed those set by the Department of Housing and Urban Development for Transitional Housing Programs.

Emergency Shelter for single adult men--The Thresholds Emergency Shelter program is designed to provide short-term shelter and supportive services to 11 homeless single men at a time. Program Personnel work quickly with the men to develop gainful employment opportunities and to secure permanent housing. By providing practical, applicable information, education and services in a condensed timeframe, men are provided intensive, "life ready" skills in the shortest period possible. The efficient process moves men into stable housing as swiftly as possible. Moreover, they have the necessary resources and tools to help ensure they can maintain their housing. In 2009, 137 single men were served by the Thresholds Program.

USS Food Pantry - Food Services --The United Southside Food Pantry has developed a multifaceted continuum of services designed to provide emergency food distribution, reduce hunger, improve nutrition, and enhance the quality of life for households in the 53204 zip code. The three tiers--healthful food distribution, applicable education on nutrition, and relevant service and referral--create a positive, proactive and integrative method for recipients to improve and maintain their quality of life. In 2009, a total of 3,928 households received emergency food distributions. This amounts to more than 12,100 people, including 6,863 adults and 5,274 children.
