Community Integration: Headwaters offered programming for 148 adults with disabilities and 182 children with special needs in 2009. 83,575 hours of training and supervision were provided to our adult participants by a support staff of 36. Our community integration program provided 31,029 hours of training and supervision in the following areas: daily living skills, academics, enrichment, sewing, shopping, cooking, swimming, recreation and leisure activities. Our adult respite program served 24 families. Ten families received free in home volunteer visitation, and 12 families received outreach and assessment services.
