Residential Services provide a continuum of care options including 5 Community Based Residential Facilities (6-7 bed), 2 Adult Family Homes (4 bed), 3 Supervised Apartments (6 bed), and an Independent Living Support Program Each resident has their own private room and is provided appropriate care, treatment, and training based on their individual needs The 57 total beds provided 20,626 day of service in 2009 Five consumers moved into more independent living settings And reflecting the focus on community integration, residents participated in 16,388 community activities that year for an average of 288 avtivities per resident The Independent Living Support Program serves individuals living in their own homes or preparing to transition into an independent setting One-to-one service that included support and training components were provided to 20 adults with disabilities in 2009

Enterpsnes were created to act as a platform for the Work Services Program and to meet the Mission in serving consumers Marthon Industnes and Bay Produce provided the environment for the employment and training of the 50 individuals enrolled in the Work Services Program, resulting in their receiving over \$103,982 in wages during 2009 MArthon Industnes, begun in 1980, performs light assembly, packaging, labeling, and mailings through subcontracts with area businesses, as well as confidential paper shredding for consumers throughout the Twin Ports area The paper is then baled and recycled Bay Produce started operation in 1986 operates two greenhouses using hydroponic technology to grow beefsteak tomatoes, grape tomatoes, and colorful bell peppers in a sustainable manner Wholesale distribution totaled 279,291 pounds of produce throughout the region in 2009 Other enterpsnes have included space rental, professional training and contracting personal care workers to a home health care agency
