This year we provided 52 grants to fulfill needs throughout the community, including tools for a workshop and training center for Chippewa Valley Habitat for Humanity, funding technology improvements for United Cerebral Palsy, and adding exercise equipment for the L.E. Phillips Senior Center. In addition, we provide educational support to area non-profit organizations regarding planned giving and endowment building and to raise awareness for the importance of members of the community to be philanthropic. We also initiate new projects for the community, host forums to promote philanthropy and provide information to our donors, provide technical assistance for non-profit organizations and grantees, track grantees' progress to ensure we are making wise funding decisions, and conduct workshops to support community non-profit organizations.
